Note 6.1 Compensation paid of Rs.63,00,000 in earlier years to a party for land of nursery acquired back is being amortized over the balance period of lease of the Club land on Strainght Line basis. The amortization for the current year of Rs.4,84,615 (previous year Rs.4,84,615) is included in depreciation.

Note 6.2 The Club land was obtained on leasehold basis from Delhi Development Authority. Lease for a part of the land has expired on 31<sup>st</sup> August, 2012 which has been renewed by the authorities till 30<sup>th</sup> April, 2013. The authorities are finalizing a policy regarding renewal of lease deeds and decision on further renewal of lease deed will be taken after the said policy is formulated by the authorities. Lease for balance part of the land will expire on 1 January, 2018.

Note 6.3 The Club has incurred a sum of Rs.4,01,285 on development of Renovation of Party Hall Toilet which is yet to be fully completed.
