

AFFIDAVIT

I, the above named deponent, do hereby solemnly affirmed and state that I am elected Hon Gen Secretary of M/s Roshanara Club Ltd and am competent to swear the affidavit:

1. That I am being the Hon Gen Secretary of the above establishment M/s Roshanara Club Ltd and well conversant with the functioning of the company / establishment and state on oath / depose this affidavit.
2. That the deponent is M/s Kajal Security & Placement Services (hereinafter referred to as the Principal Employer) is an independent legal identity and Principal Employer in accordance with the provisions of the Contract Labour (Regulation & Abolition) Act, 1970 and rules made there under.
3. That the establishment of deponent has entered into an agreement with M/s Kajal Security & Placement Services to carry out the work as per annexure on _____ for providing the 200 number of workers, which shall remain in force from 1st May 2018 to 30th April 2019.
4. That those workers deployed/shall the deployed by the deponent and performing the same & similar kind of work as being done by the worker(s) directly employed by the Principal Employer are being /shall be paid the same wages as applicable to the directly employed worker(s) of Principal Employer.
5. That the deponent undertake that each and every worker deployed by the deponent is/are being /shall be paid not less than the minimum rates of wages fixed for their category of employment from time to time by the Govt of NCT of Delhi under the provisions of Minimum Wages Act, 1948 including overtime/weekly-off etc. and it shall be paid through the account payee cheque /ECS / Bank Transfer (other than workers engaged in construction work / daily paid). The payment of wages will be made in the presence of authorized representative of the deponent (Principal Employer) and duly verify by him/her.
6. That the deponent shall ensure that all contractors provide (s) all the statutory benefits under the applicable Labour Laws in respect of all the worker(s) deployed/shall be deployed in the premises of the deponent (principal employer), failing which the same shall be provided by the deponent as per the provisions of the Contract Labour (R&A) Act, 1970 and the rules made thereunder.
7. That the process(es)/work/job(s) on which the contract workers are to be deployed/engaged is/are not abolished by any Authority or Board under the provisions of Contract Labour (R&A) Act, 1970.
8. That the deponent has uploaded the required information and documents as per check list in their website www.roshanaraclub.in and the website is not be password protected and will be updated every month, further the required information and documents shall not be removed from the website without prior permission and changes, if any shall be intimated to the Registering Officer.


